IN VIEW OF APPROVED APPLICATION FOR GERMAN CITIZENSHIP**

**Requirements:**

- 1 Duly accomplished Affidavit of Renunciation;
- 2 **Personal appearance** of the applicant at the Philippines Embassy in Berlin or at the Philippine Consulate General in Frankfurt.

*For applicants who can not appear in person at the Philippine Embassy in Berlin or Philippine Consulate General in Frankfurt, may send their application by mail provided that the Affidavit of Renunciation is signed by a German Notar and the State Judicial President (Landgericht) where said Notar is registered.*

- 3 Valid Philippine passport;
- 4 Original Einbürgerungszusicherung;
- 5 If the Certification/Affidavit will be released via mail, submit a self-addressed stamped envelope (registered) for return of the certificate and affidavit;
- 6 If applying via mail, please send payments by bank transfer. Please send EXACT amount (exclusive of bank charges) and attach a photocopy of the proof of payment to your accomplished Application form.
